

SB 0160 – Relating to Ad Valorem Tax Exemption For Deployed Service Members – Expands the military operations that qualify a service member deployed in support of such an operation in the previous calendar year for an additional ad valorem tax exemption; providing an extended deadline and specifying procedures for filing application for such tax exemption for qualifying deployment during the 2014 calendar year, etc.

SB 0184 – Relating to Military and Veterans Affairs – Requiring the application form for an original, renewal, or replacement driver license or identification card to include a voluntary checkoff authorizing veterans to request written or electronic information on federal, state, and local benefits for veterans; creating the Military and Overseas Voting Assistance Task Force within the Department of State; providing legislative findings regarding continuing education for veterans of the United States Armed Forces, etc.

SB 0222 – Related to parking for Disabled Veterans – Requiring the governing body of each publicly owned or publicly operated airport to grant free parking to any vehicle displaying specified license plates for disabled veterans; clarifying that such license plate, rather than “DV” license plates, are exempt from certain parking fees charged by a county, municipality, or an agency thereof, etc.

SB 0404 – Relating to Small Business Financial Assistance – Creates the Veterans Employment Small Business Grant Program within the Department of Veterans Affairs; requiring a small business to apply to enter into an agreement with the corporation to receive grants; requiring the corporation to notify the appropriate regional small business development center of a small business’ participation; providing for termination of the program, etc. (See House Bill 263)

SB 0518 – Relating to Bronze Star License Plates- Creates special license plate for recipients of the Bronze Star medal, etc.

SB 0538 – Relating to Annual Sales Tax Holiday for Veterans of the United States Armed Forces- Creates an annual sales tax holiday for veterans; specifying items that are eligible for the sales tax holiday; defining the term “veteran” for purposes of the sales tax holiday, etc. (See House Bill 279)

SB 0604 – Relating to Mental Health Services in the Criminal Justice System – Expands eligibility for military veterans and service members for certain programs. Expanding the definition of “veteran” for the purpose of eligibility for veterans’ court, to include veterans who were discharged or released under a general discharge. (See House Bill 439)

SB 0666 – Expanding the list of acceptable forms of identification for certain voter registration applicants to include veteran health cards, licenses to carry concealed weapon or firearm, and certain government issued employee identification cards, etc.

SB 0772 – Relating to Department of Agriculture and Consumer Services- Waives specified license and registration fees for honorably discharged veterans of the U.S. Armed Forces, spouses of such veterans, or business entities that have a majority ownership by such veterans or spouses of such veterans.

SB 0778 – Relating to Homestead Tax Exemption/Spouses of Combat-related Disabled Veterans – Joint Resolution proposing an amendment to the State Constitution to authorize the discount on ad valorem taxes on homestead property which is received by certain veterans who have permanent, combat-related disabilities to carry over upon the death of the veteran to the benefit of a surviving spouse until the surviving spouse remarries or sells or otherwise disposed of the property and to specify that the discount is transferrable to another permanent residence if the surviving spouse remains unmarried, etc.

SB 0816 – Relating to Homestead Property Tax Discount for Disabled Veterans – Providing for the transfer of a certain discount on ad valorem taxes on homestead

property to the surviving spouse of a specified disabled veteran under certain circumstances; providing for the transfer of the discount by the surviving spouse to a new residence under certain circumstances, etc.

SB 7016 – Relating to Interstate Compact on Educational opportunity for Military Children – Reenacts provisions of law establishing and implementing the Interstate Compact on Educational Opportunity for Military Children and provides for future legislative review and repeal of the Compact on July 1, 2019. The compact is an agreement between states that is designed to assist member states in uniformly addressing key educational transition issues in enrollment, placement, attendance, eligibility, and graduation.

Effective: Except as otherwise expressly provided in this act, this act shall take effect Apr. 9, 2016, or if this act fails to become law until after that date, it shall take effect upon becoming a law and operate retroactively to April 9, 2016.
